MISSION STATEMENT: The Disaster Relief Ministry of American Baptist Men seeks to serve those affected by local, state and federally declared disasters, with a core ministry of post disaster cleanup of homes and property. This work is done in cooperation with ABC Regions, and the wider disaster response community. In so doing we will further fulfill our Christian mission by demonstrating the compassion of Christ and ministry of wholeness and renewal.

ABMen Disaster Relief is a volunteer-driven ministry that provides assistance to those affected by local, state and federally declared disasters. We respond with volunteer laborers specializing in post disaster cleanup. Our focus is removing storm-damaged possessions, sheetrock, paneling, insulation and floor covering etc. as necessary for the home to dry out such that rebuilding can begin. Any water or mud remaining after the storm or fallen trees and windblown debris are also removed by the volunteers. Our response is usually initiated within 48 hours of a valid request for assistance.

American Baptist Men have been doing disaster response for decades through volunteering for mission trips and construction projects. In the 1990s ABMen's Disaster Relief Ministry was organized using a 40' trailer as an operational base for sleeping and tool storage. We soon learned that we could find lodging in local churches, fire halls etc. The large trailer was replaced with 16' and 12' trailers which can easily be towed with a pickup truck or large SUV. In 2010 we erected an 1800 square foot storage building at the Parchment Valley Conference Center for tool and equipment storage and training.

Generally responses are initiated when a request for assistance is received from a leader or pastor within the West Virginia Baptist Convention, the VOAD Director (WV Voluntary Organizations Active in Disasters), or a representative of a county office of emergency services .

ABMen Disaster Relief is largely subsidized by grassroots donations from individuals and local churches. Grants for teams may also be available from Home Mission Action Team funding from American Baptist Home Mission Societies. All donations should be specifically identified as ABMen Disaster Relief
